



# 5 Year Limited Warranty

United Trailers Inc. 19985 County Road 8 Bristol, IN 46507

Does hereby warrant the below listed product for five (5) years to the original purchaser.

This warranty covers defects in materials and workmanship by United Trailers and does not include warranties on components or products used in the manufacturing of this product. These components or products may or may not have their own warranties, examples include: tires, wheels, axles, jacks, couplers, fiberglass or TPO components, aluminum components, seals, windows, doors, awnings, electrical and plumbing components. Components or products warranted by our suppliers are not warranted by United Trailers. Any warranty on these components or products must be presented to the respective manufacturer according to their procedure for warranty claims. Paint and undercoating are not included in our warranty.

Please note that due to extreme temperatures and situations, the glued exterior side panels on some models are not covered in this warranty. In the event that these conditions arise and cause the glued seams or side panels to come loose from the sidewalls, United Trailers will either apply screws to the trailer or will gladly send the screws to you. (Labor is not included)

The United Trailers warranty will be honored if the trailer is returned to United Trailers or a repair facility authorized by United Trailers. Reasonable notification and time will be allowed for performing warranty repairs. Loss of time, inconvenience, loss of use, rental of substitute equipment; loss of revenue or other commercial loss is not included under this warranty. Also, any service charge, towing charges, or transportation costs are the responsibility of the purchaser.

This warranty is void if the product has been misused in any way. Other exclusions are as follows: Overloading, lack of preventive maintenance, or use for other than what this product is designed for. Acts of nature are not included in this warranty. Roof damage from snow/ice buildup, or other events beyond the control of the manufacturer or United Trailers, Inc. Damage due to normal wear and tear, exposure to salt, or corrosive chemicals like calcium and magnesium chloride used on today's highways to melt snow and ice. Damage resulting from an accident. If the product has been modified in any way without prior approval the warranty will be void. United Trailers reserves the right for final decisions as to whether the initial purchaser misused the product.
